Selection in to the Order of the Arrow is a privilege, not a right. Selection and induction of an adult Scouter should take place only when the adult's job in Boy Scouting will make the Order of the Arrow membership more meaningful in the lives of the youth membership. It must be for the purpose of adult recognition

Each year upon holding a troop or team election for youth which results in at least one youth candidate being elected, the unit committee may recommend one registered adult to the lodge selection committee. Troops or teams having more than 50 registered active youth members may nominate an additional adult for every 50 registered, active youth, or fraction thereof (Example, up to 50 youth-1 adult; 51-100 youth-2 adults etc.).

The following conditions are the basis for candidate selection and must be fulfilled to be considered. Make a brief statement regarding the individual for each item. 1. Camping Requirement

The camping requirement, which applies to youth candidates, applies to adults. The adult must have experienced fifteen days and nights of Boy Scout camping **during the two-year period before the nomination**. The fifteen days and nights must include one, but no more than one long-term camp consisting of six consecutive days and nights of long-term camping, approved and under the auspices and standards of the Boy Scouts of America. The balance of camping must be overnight, weekend or other short-term camping
